BSTP Module 13 Musculoskeletal System, Skin, Subcutis and Mammary Gland

**2nd – 6th December 2013
Department of Pathology, Cambridge**

The BSTP are able to offer a **free** place to one resident on each of our training modules (worth £700), in addition successful candidates will receive a year's **free** membership of BSTP worth £50.

Applicants must be stipendiary students studying a relevant subject, including veterinary pathology residents, or students with a relevant PhD project.

All applications must be made by email to the BSTP Secretariat bstpoffice@aol.com by **1st October 2013**. Applications will be assessed by the BSTP Council on merit.

Criteria for application:

The applicant must submit a brief description of the relevance of the module to their training or career needs and provide the following information:

- A brief CV
- A covering letter stating why the particular module would be of interest to them
- A letter from their supervisor confirming that they are a resident
- A completed BSTP membership application form
- Up to 3 suggestions for future educational activities/topics that would be helpful to their training in toxicological or experimental pathology.

The successful resident will be expected to:

- Make their own travel and accommodation arrangements, once their place is confirmed
- Attend the whole module
- Write a short report for the BSTP website

By applying, all applicants consent to their details being added to the BSTP mailing list and you will automatically receive future information when it becomes available. Your details will not be passed on to any other organisation without written permission from yourself. *The BSTP is registered with the UK Information Commissioners Office (ICO) - Data Protection Act and in addition to its UK responsibilities, the ICO has an international role including co-operation with similar organisations in the rest of Europe and with the European Commission.*

Successful applicants will be notified on or before **1st November 2013**.

BSTP 2013/2014 BURSARIES

The BSTP grants a travel bursary of £500 for a member of the society to attend a recognised scientific meeting, and give a platform presentation or present a poster on a toxicological pathology subject of their choice. There is no limitation on the toxicological pathology experience of the applicant or which meeting is chosen.

All applications must be in writing to the Honorary Treasurer of the BSTP via the BSTP Secretariat.

Applications will be assessed at Council meetings. If there is more than one candidate, the application will be picked by judgment of the scientific merit of the presentation.

Criteria for application:

1. An application to present a paper or poster at a meeting of recognised scientific merit.
2. The application must contain at least a brief summary of the presentation, preferably a PowerPoint handout of draft 1.
3. All successful alternative funding details must be disclosed.
4. The application must be accompanied by a copy of the applicant's CV and a letter of recommendation by their Head of Department.
5. The successful applicant must be willing to write up the presentation as a short case report/article for the BSTP Newsletter/Website.

There is no limit on the number of times each of a member of the society can apply for this bursary or the number of times it will be awarded per year, but please note that the BSTP Council's decision as to who is the successful candidate will be final and binding.
